Equipment Hire Terms & Conditions

Term: The rental term begins on the date equipment is received for a minimum term of 5 days or as agreed until the equipment is received back at our inventory centre in full working order. After the expiration of any minimum term, rentals for a fractional period shall be at the daily rate. Monthly rates are available but a monthly term commitment in advance of shipping must be made. After such commitment the minimum term is 28 days from date of equipment received. All rental equipment must be returned by 2pm.

Terminate: Either party can terminate the agreement by giving five days notice.

Carriage & Packing: All equipment shipped to the customer's site at the customer's expense using overnight delivery services. To maintain a timely schedule all outbound shipments are made using overnight express service unless otherwise specified. Return shipments to be arranged by the customer, or by calling 01483 755957 to arrange collection, at additional cost. It is the customer's duty to return the equipment at the end of the hire period, failure to do so will incur additional rental cost.

Checking Equipment: It is a condition of this rental that the equipment is checked upon receipt and up to and within the first 12 hours from receipt of goods. All equipment shipped has been recorded to identify use by the hiring party. Any attempt to use equipment in a defrauding manner may result in prosecution and a ban from services.

Faulty Equipment: If equipment is found to be defective on receipt, the client must notify the hire company at the time of the event (not after). We will replace or repair with the minimum possible delay.

Notification of faults after the event will be charged for. Any attempt to repair without our consent will be in breach of this agreement and charged accordingly.

If a piece of equipment develops a fault due to poor storage or handling during hire, then any repair arising from this will be charged for.

Any use of equipment against the manufacturer's instruction and contradicting the normal use of the instrument (indicated by means of an appropriate test method) would be liable to full repair cost charges and possible ban on hiring.

This includes ingress of water, instrument contamination, damage to instrument and abuse through lack of knowledge.

Payment Terms: All invoices are net and payment must be paid 30 days from date of invoice. Any invoices not paid in full within the state period will be subjected to a late payment charge of 8% per 28 days or part thereof. Hire to new customers will only commence upon receipt of payment prior to despatch.

Value Added Tax: Prices do not include VAT, this will be charged at the current standard rate.

Limitations of Liability: In no event, whether as a result of breach of contract or warranty, shall Pollution Monitors Ltd be liable for any consequential, incidental or exemplary damages, including without limitation, any loss of profit or revenues, loss of use of any equipment, or any other equipment, damage to other equipment, cost of substitute equipment or down-time costs.

Insurance: All equipment must be insured by the customer for the duration of the rental, which must include transit insurance.

Pollution Monitors Ltd warrants the equipment in normal use will meet the operating specifications. If any equipment shall require repair or re-calibration, the customer shall immediately notify Pollution Monitors Ltd and obtain consent before any remedial action is taken or any equipment is returned. The sole obligation of Pollution Monitors Ltd under the forgoing warranty shall be to repair, re-calibrate, or at its option, replace any equipment that shall fail to meet the said warranty at its expense, and the right to receive such repairs, re-calibration or replacement shall constitute the sole and exclusive remedy of the customer.

The forgoing warranty shall not apply to any damage to equipment caused by accident, misuse or abuse and Pollution Monitors Ltd shall not be responsible for any delay or failures in making repairs, re-calibration or replacement due to non availability of parts or labour, strikes, delays in transportation or other causes beyond its reasonable control.
